# Plastic Package, Inc. Expands in Hawaii

**Sacramento, Ca (June 18, 2015) - Plastic Package, Inc.** Plastic Package, Inc., a California based plastic container manufacturer has entered into an agreement to acquire the assets of Creative Malnove Hawaii. Serving the Hawaii market, Creative Malnove Hawaii is a manufacturer and distributor of both plastic containers and folding cartons. The sale is expected to close before the end of June.



“This acquisition will significantly enhance our ability to serve our existing Hawaii customers as well as allow us to serve the broader Hawaii market.” According to Jim Kaye, Chairman. The factory currently occupies a 22,000 square foot facility in Kapolei, a suburb of Honolulu and will continue to operate there. It produces and sells plastic trays and containers as well as

folding cartons primarily to the candy, supermarkets and food service industries.

The existing Hawaii operation will be expanded to incorporate products currently supplied from Plastic Package’s mainland plants. Brett Troxel, Operations Manager, will continue to run the facility. He said, “The association with Plastic Package will give us access to in depth expertise in thermoforming as well as the buying power of a larger organization. We will also have the possibility to expand our reach through capital expansion. We are excited by the prospects.” he said.

“The addition of Hawaii adds a third factory to our Company. The other plants are located in Sacramento, California and La Porte, Indiana. The acquisition is in line with our plans to be a premier supplier to candy, bakery and food service customers nationwide” according to Mike Miller, President of Plastic





Package, Inc. It will operate as Plastic Package of Hawaii.

Plastic Package is a family owned business started more than 30 years ago. Its principal offices are in Sacramento California.

Creative Malnove Hawaii is owned by Malnove Holding Company, Inc. one of the largest nonintegrated folding carton manufacturers in the U. S.
